Chris Kuhn provided an update on market values and overall fund performance. It was noted Herndon was slightly behind for the month, however had a good quarter. Graham had a great

month with a very nice return. Mr. Kuhn advised the Board there is a need to transfer funds to the Administrative account to provide liquidity for upcoming benefit payments. He recommends transferring \$300,000 from Brown.

Kirk VanDagens spoke briefly about the reversal this year on performance of large value. Large value was in the top 10% last year; however this year has fallen to the bottom 10% due to a frustrating environment. It was noted the three year return is still beating the benchmark. All investments with PNC are ahead of their benchmarks. An account status update was provided as well as an investment performance update.
